



Dear American Patriot,

Militant Islamists nearly destroyed my life.

Now, I fight tirelessly every day to prevent the same sword of radical Islam from piercing this nation, as it did mine as a child.

I am Brigitte Gabriel, and this is my story.

When I was 10 years old, Islamic soldiers launched rockets into my family's home in our Christian town in southern Lebanon, destroying our house, and seriously injuring me.

As their war on the "infidels" raged around us, my parents and I moved into an underground 10 x 12-foot bomb shelter, where we lived for the next seven years as my beloved country was destroyed around us.

To get water, we had to crawl into a ditch on our way to a spring, to avoid Islamic snipers. We almost starved, often surviving on merely weeds for food. We feared for our lives every single day. It is nothing short of a miracle that I survived.

After several perilous years, I eventually found safe-haven in Israel, before subsequently becoming a proud citizen of the greatest nation on earth, the United States of America.

Though overcome with joy, I did not know at that time, the calling and responsibility I would take on to repay this nation for all it gave to me.

But on September 11, 2001, I sat in front of the television with my children, tears streaming uncontrollably down my face, as I watched a quintessential symbol of Western values, the World Trade Center, come crashing down before my eyes.

As I had asked my parents while living in our bomb shelter, my daughters turned and asked me: "*Why did they do this to us?*"

I gave them the same answer my parents had given me: "*They hate us because we are not Muslims. To them, we are infidels who deserve death.*"

In the immediate aftermath of 9/11, I couldn't even leave my house. I was so shell

shocked from my childhood memories, that I couldn't bear to face the demons of my past.

But this time, I was no longer the child. Now, I had my own children to protect, as my parents so lovingly protected me.

This was the turning point that drove me to create what is now the largest, and most powerful National Security Grassroots Advocacy Organization, **ACT for America**.

With over 750,000 members and over 1,000 Chapters, our organization is the unequivocal tip of the spear for combatting radical Islamic terrorism, right here in our own backyard.

Facts About Islam You Need To Know



- 23 percent of the world's population is Muslim – 1.6 billion. About 75 percent of Muslims living in the Middle East believe in Sharia law. Since late 2015, 29,000 Muslim refugees have entered the United States. Many politicians are trying to increase those numbers dramatically!
- There are now 2,800 mosques in the U.S., 2,200 of which were opened after September 11, 2001. Some experts believe that over 80% of these are operated by the Muslim Brotherhood, a terrorist organization!
